TRIBECA FILM FESTIVAL PRESENTATION

Doug Bennett presented the Tribeca Film Festival opportunity and requested \$35,000 in LHP funding to support the **Louisville Film Office (LFO)** as they host an industry event in New York City, June 2025. Louisville Tourism will provide **LFO** with all necessary marketing and event support. After a brief discussion, a consensus to vote was reached by the group.

Chairman Eamon O'Brien requested a motion to authorize an expenditure of \$35,000 to support an effort by the Louisville Film Office to drive film and entertainment related business to Louisville, KY through an industry cocktail event sponsorship during the Tribeca Film Festival held in New York, NY in June 2025. Louisville Tourism will negotiate the particulars of such potential events and sponsorships.
